 - Chairperson Matt Peters called the Board Meeting to order at 10:38 a.m. ET. Also present were Iris Ferrecchia, Hollie Swain, Gwen Glover, Kathy Thelen, Gus Paiva, Richie Thelen, Laurie Kinnard, Dr. Dwight Koeberl and Brian Pawlik.
- II. Approval of Meeting Minutes for May 23, 2016. Minutes approved once corrections made.
- III. Treasurer's Report

Financial Report for 2016 2nd Quarter was presented, discussed and approved.

Also new bank signing authorities were discussed and Hollie is to set those up accordingly.

GSD la and Kidney Disease

GSD I Kidney Disease is marked by enlarged kidneys, tubular dysfunction, glomerular (filter) dysfunction, proteinuria (protein excretion in urine) and kidney stones. The most common issue is glomerular hyperfiltration, which is similar to the kidney disease occurring in diabetes.

High blood pressure in GSD is most commonly related to kidney dysfunction. Increased pressure in the glomerulus (that serves as a filter) causes high blood pressure and protein excretion. ACE inhibitors (ACEi), such as Enalapril, Ramipril, Lisinopril, Losartan – Cozaar, Valsartan – Diovan are used to lower the pressure in the glomerulus (kidney) and help to prevent on-going damage.

A European Study on GSDI in 2002 claimed that 100% of GSD I patients had abnormal protein excretion by 24 years of age. In that same year Wolfsdorf and Weinstein proved that patients with kidney disease had worse metabolic control. An Italian study (2005) has shown slower progression in kidney function with the use of medications previously mentioned. Treatment with medications, however, did not prevent development of chronic kidney disease. In the Netherlands, Martens (2009) correlated optimal metabolic control with reno-protective effects on development of microalbuminuria. ACEi did not prevent progression of kidney disease, but none of the patients had good control. The next Italian study (2015) supported the importance of good metabolic control. Since complication in GSD has shown to

be preventable, we hypothesized that kidney disease could similarly be ameliorated if metabolic control improved in the patients taking ACE inhibitors. In our population, only 11.7 % (23/195) of GSD Ia patients, and 13.3% (6/45) of GSD Ib patients developed abnormal protein excretion. It was most common in age group 16-20, which is consistent with other chronic conditions (lack of compliance in young adults). 11/14 patients with improved metabolic control and ACEi had diminished amount of protein in their urine. Three participants who worsened while on ACE inhibition had no change in their metabolic control, but no patient developed chronic kidney disease. Dietary compliance with strict metabolic control is likely to prevent the onset of kidney disease. Metabolic control plus medication for the patients with established GSD Ia glomerulopathy is necessary and progression of glomerulopathy can be reversed.

During pregnancy, ACEi must be discontinued, but no long-term worsening has occurred in any pregnancies followed by our institution (49 deliveries). The GSD population is also very prone to kidney stones, which is not correlated with metabolic control. Citrate supplementation prevents this complication. Kidney disease was not detected in any of the 135 patients with the ketotic form of GSD (types 0, III, VI, IX) even though they are on very high protein diet. Liver transplant does not prevent GSD I kidney disease, and anti-rejection medications are toxic to the kidneys.
